Rules

The Series will be governed by the rules as defined in the *Racing Rules of Sailing* and the *Sail Canada Prescriptions 2017 - 2020*.

Eligibility

The Series is open to all sailors who hold a valid membership of *Sail Canada* or an *ASA* affiliated club.

Fees

There are no fees. This is a free event.

Awards

Awards will be presented to 1st 2nd and 3rd place finishers at the end of the season.

Schedule

Registration: With the Race Officer prior to the race starting. See attached *Registration Form*
Skippers Meeting: All information is included in the *Sailing Instructions* available from the Fleet Captains and in the Clubhouses.
Start of race: June 27 – August 08 will be 19:30
Start of race: August 15 – Aug 29 will be 19:00
Number of races: 10

Course

The triangle course in the attached course diagrams in shows the course and the order in which marks are to be passed and the side on which each mark is to be left.

Start Sequence

Each boat will start at its assigned time as listed in the 2018 Handicap Start Times that are available on the SBYC and EYC web sites and on the club bulletin boards.

Scoring

One race constitutes the series

When fewer than 5 races have been completed, a boat's series score will be the total of her race scores.

When 5 – 8 races have been completed, a boat's series score is the total of her race scores excluding her worst score.

When 9 or more races have been completed, a boat's score is the total of her race scores excluding her two worst scores.

Radio Communications

Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communications that is not available to all boats.

The Race Officer may communicate with the race fleet on channel 72.

Disclaimer of Liability

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race.

The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the regatta.

Insurance

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$1,000,000.00 per incident or the equivalent.

Rights to Use Name and Likeness

In participating in this event, a competitor automatically grants the *Organizing Authority* and the sponsors the right in perpetuity, to make, use or show, from time to time and at their discretion, any motion pictures, still pictures and live taped or film television and other reproductions of him/her during the period of the competition for the said event in which the competitor participates and in all material related to the said event without compensation.
